# **General Manager's Report - Albertson**

Executive Director Update Board of Directors Meeting Aug 29 2024 Overview:

- In Aug we have focused on fundraising events like Sunset in Stereo, National Radio Day and So Long Summer and 2 events coming up in Sept (see Outreach section below)
- Bonterra testing period scheduled for Sept (before Radiothon and before Becka travels)
- New job posting for a PTE Events Coordinator in Sept. with a goal to hire by Nov.

#### Operations

- Lots of outreach and fundraising to engage with our population
- Tons of ticket giveaways to build community
- All campaigns launched for So Long Summer, Alvvays and NRD.
- We will continue to accept donations for IIRA through Aug.
- IDOC Concerts are happening in Sept 30

#### Financial

- As of today our bank account balances are \$26,789.38 in the main account, \$1843.51 in RRF and \$3500 in the backup account.
- UW brought in \$5953
- While we didn't have any Cars Donations in July, two were started.
- Radio Boise Undercover rallied \$1143.40 ticket sales and \$240 in and merch
- At "Sunset in Stereo" we got \$185 in ticket sales, \$97 in merch sales and food costs were \$133.77 which was paid for by Mark and Tracy.
- Paypal Giving Fund donation \$42.52
- NRD netted \$3673!!! 42 donors Wayne did most of the work on this and deserves high praise.
- Ken Harris's event, "So Long Summer" netted \$150, however, 5 tshirts are promised to the headliners and that will cost \$150

### **Governance Committee - Shirrod**

Resolution for two signatures for any purchases greater than \$2500

Motion to approve \$2500 limit for signature by signatory officer - Lopez, Second - Musser, Motion passed 4-0

#### **External Affairs Committee-Shirrod**

CAB meeting occurring September 8. CAB looking for direction/suggestions. Musser suggests looking at the framework and giving an honest assessment of programming. Lopez suggested giving CAB specific requests. Shirrod suggests looking at programming and public service participation

# **New Business**

Proposed payment plan to IRS for \$8202. Motion for approval to pay \$1000 and consequently agree to pay \$500/month with the goal of paying off faster, up to \$1500/month - Motion-Lopez, Second Shirrod, Passed 4-0.

Shirrod and Musser are working on a 5 year strategic plan with the goal of presenting to the public in January, 2025. They feel the Board of Directors need to establish a vision for the station. They propose work groups composed of a board member, staff member and public members targeting resources, metrics and implementation of their specific area. The Board of Directors would be the steering committee. There would be checks and balances including the CAB.

There being no other business or comments, The Chair adjourned the meeting at 7:51 PM
